Job Description & Responsibilities

Conservation Day Camp Counselor

Time Required: 2 days (June 10th & 11th) from 8:00am to 3:30pm

Location: Chenoweth Trails, 440 Greenville-Nashville Road, Greenville, OH 45331

General Responsibilities

- Assist in conducting age appropriate, educational environmental programs for youth
- Provide a safe and positive environment for youth development
- Serve as a good role model for campers
- Be directly responsible to the camp directors and perform duties as requested
- Work cooperatively with all camp personnel, volunteers and other counselors
- Arrive on time and with the proper materials for assigned responsibilities

Counselor Responsibilities

- Be with my group of approximately 18 campers at all times
- Get to know each of the campers in my group personally and by name
- Have all campers, including myself, check in medications with the nurse
- Make sure that all of my campers are familiar with camp site, rules and daily schedule
- Help campers take care of personal possessions
- Make station volunteers or camp directors aware of illness or injury
- Set a good example by not using profanity or telling off color jokes/stories
- Not have tobacco, alcohol or illegal drugs in my possession, or use these substances during camp
- Never punish a camper by ridicule or physical punishment, be patient
- Urge safety at all times. Take time to explain how and why to do something safely
- Ensure that all campers are involved in all activities. Make sure no one is excluded
- Remember that camp rules apply to me as well as the campers, I am setting an example
- Be flexible, plans might change and the weather is unpredictable

Job Description & Responsibilities

Conservation Day Camp Counselor

Specific Responsibilities

- Arrive at 8:00am to check in and wait for campers to arrive
- Stay until 3:30pm or until all campers have be picked up
- If a program ends early and there is free time, keep the campers busy with games/activities
- Always keep your group together and do a head count frequently
- Know the schedule- make sure you lead your group to each station at the proper time
- Have respect for the station presenter by providing help with needed, quieting the group before starting and helping with clean up
- Make sure your entire group makes it through the lunch line
- Make sure everyone cleans up his/her trash after lunch
- Participate in activities yourself with great enthusiasm
- Bring your group to the closing area to help with dismissal each day

Discipline Policy

- You will be responsible for handling campers talking, interruptions, rudeness, horseplay, etc.
- If you have continuous problems with a camper, or if a camper causes major problems such as profanity, endangering others or sexual harassment, bring them to a camp director
- Counselors are to set the example...campers look to you for leadership!

Weather Policy

- You will be made aware of approaching bad weather
- Lead your group to the designated area immediately, but calmly. Try not to cause panic
